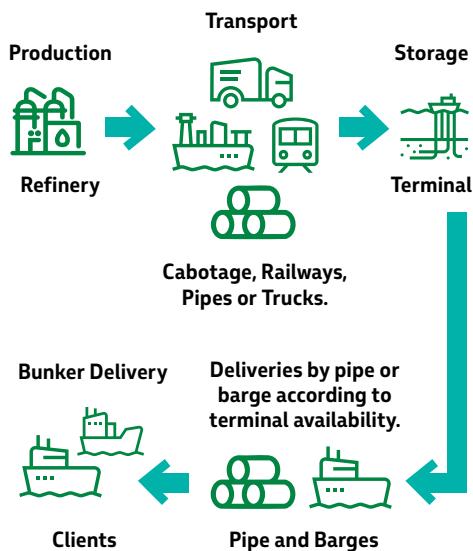

The main products of our Marine Fuels portfolio includes: VLS B24*; VLSFO 0.5%S, VLSFO 0.5%S LV, MGO 0.5%S and LSMGO 0.1%S.

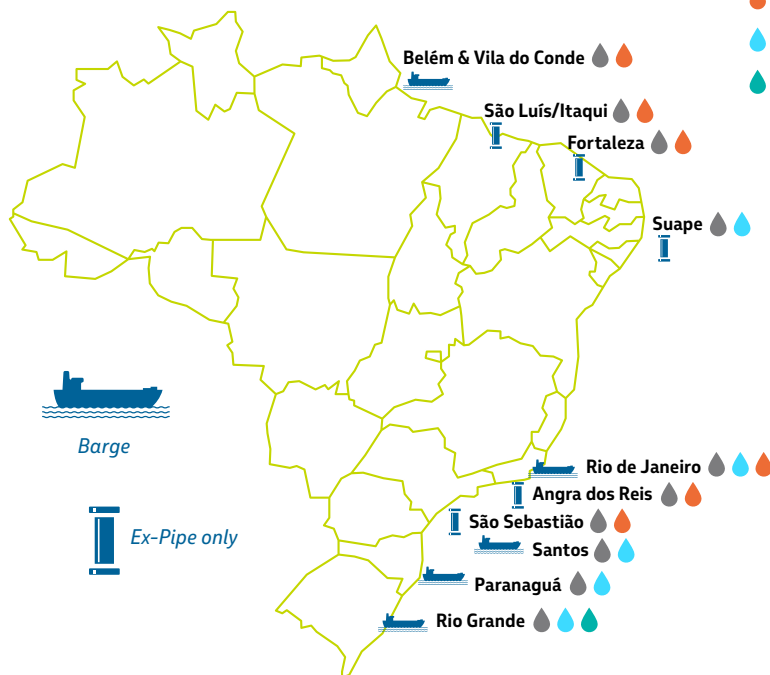
